

TERMS AND CONDITIONS

THIS LEAGUE IS OPERATED BY SUPERSTADIUM MANAGEMENT COMPANY (SMC).

By signing this contract I become the sole person responsible for my teams affairs and as such, I shall make sure that all the players in my team are aware of the rules of the league and of their individual obligations.

- I understand that if my team's conduct is in anyway in conflict with the SMC's general rules and regulations outlined in the SMC Players' Handbook then my team may be ejected from the league. This is completely at the discretion of SMC, who's decision is final, and I will indemnify the SMC for any losses arising thereof.
- I confirm that I am responsible for the conduct of my team whilst at the venue and that this contract obligates me to cover SMC for the cost of repairs for damage to the property by my team. I acknowledge that alcohol and smoking is not permitted at the venue, (other than those areas designated for such purpose), and players who are thought to be under the influence of alcohol will not be allowed to play.
- I confirm that I'm personally responsible for the payment of the season's subscription fee and the match fees of the team. I understand that if my team does not fulfil a fixture, or that there are less than 4 players available to play, that I'm liable for full match costs as detailed in the League Handbook. I also confirm that if my debts at any time exceed two weeks in arrears that I will be accountable for a administration fee at SMC's discretion (minimum £5 per week) until the debt is settled and if my team fails to fulfil 2 consecutive fixtures the team will be ejected from the league, at the discretion of the SMC, and I will be accountable for the team's fees for any outstanding fixtures for the duration of the season. If I fail to attend a game without notifying SMC than I shall be liable for my team cost and that of my opponents. I shall also forfeit the match at a score of 2-0.
- I confirm that the SMC reserves the right to remove my team from the league if my team's debt exceeds 4 weeks in arrears. You will also be liable to cover the costs of a third party if they are required to recover any debts.
- I understand that the players registered to my team for this season are not eligible to play for any other team in cup competitions. They may play in a league game from time to time for another team within the same league providing it is no more than 2 consecutive games and a maximum of 4 (no substitutes are to be used by any team borrowing players). You can be registered to as many teams as you like providing the teams do not participate in the same 'division'.
- If during the season there is a change of team manager, or the team manager's details, for whatever reason then I accept that it is my responsibility to inform SMC as to the name of the new team manager and/or new details and, until such written notice is received and acknowledged by SMC, I will continue to be liable for all team related debts.
- I agree that the SMC shall not be held liable in for any personal injury to any user in connection with the league. My team are informed that they play in the league at their own risk and are advised to carry personal injury insurance.
- I accept that the SMC may, prior to the season commencing, increase or decrease the number of divisions and teams in those divisions from those advertised dependent on the number of teams wishing to take part. In the event of insufficient teams to form one division I accept that the league start date may be postponed until such a time that there are sufficient teams available I understand that my application is not confirmed until my cheque has cleared. I accept that the SMC have no obligation to accept my application and reserve the right to refuse admission to the league for whatever reason.
- I would like to enter the team into the League as stated overleaf. As manager, I have read the Players' Handbook and agree to those terms therein (copies of the handbook are available from the organiser's office indicated on the front of this sheet). I agree to read and abide by the rules and disciplinary procedure laid down by the local Football Association, (A booklet can be obtained from your local F.A. Headquarters detailing the rules and procedures). I acknowledge that I must give 7 days notice for a game cancellation. If a cancellation is made within seven days then I am liable for both my team and my opponents match fees and I forfeit the match at a score of 2-0. I accept that I will only be informed of the exact details of cup draws one week before the competition.
- I confirm that the details given overleaf are correct and that, for Corporate Leagues, I have approval from my Company to enter a team into this league under the company's name and that I am an employee of the company.
- I confirm that I am over 18 years of age.
- I confirm that this is a contract to fulfil all my team's fixtures for one full season and to pay SMC accordingly. Should I wish to withdraw my team from the league I accept that I am liable for my team's fees for the remainder of the season.
